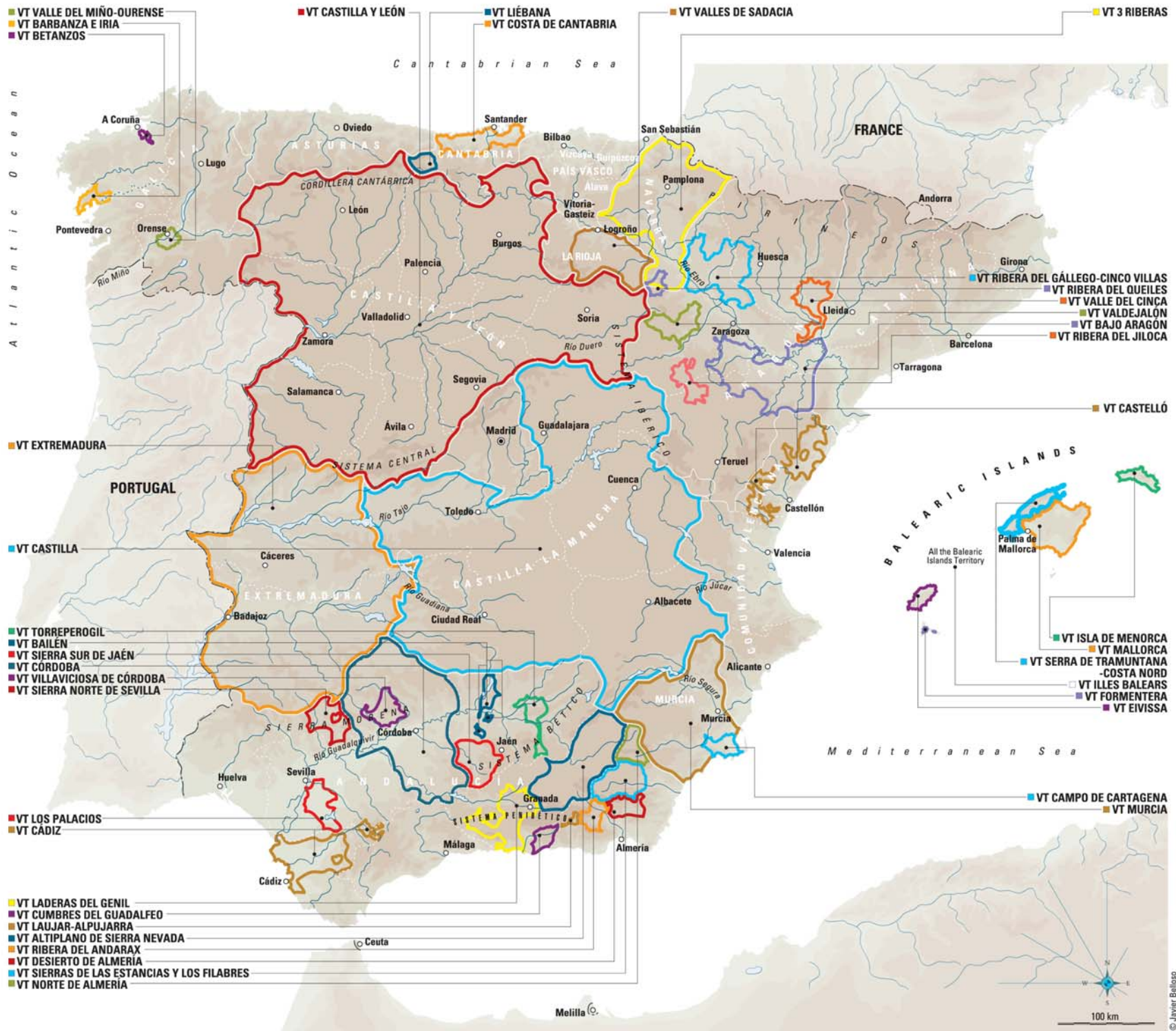

### Did you know that...

**IGP Wines**  
It possesses a certain quality, reputation or other specific characteristics attributable to its geographical origin. At least 85% of the grapes must come exclusively from the geographical area. Its production must take place in the geographical area. Distillation is obtained from grape varieties belonging to Vitis vinifera and other types of the Vitis grape. Regulation (EC) 1234/2008 DOUE L 334, 12/12/2008, p. 7

**Country Wines - CW (Vinos de la Tierra - VT)**  
These products come from certain areas of Spain where a perfectly identifiable wine is made with definite local characteristics, in compliance with vinicultural and oenological standards.
